Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 2. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
 - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1.2 FINANCIAL CREDIBILITY:

(i) Turnover: The tenderer should have achieved a minimum gross turnover of **Rs.50,14,770/-** (**Ru pees Fifty Lakh Fourteen Thousand Seven Hundred Seventy only) per annum** in his/her b usiness (in the same name in which he/she is submitting his/their offer) during any one of previous four financial years, i.e. **2020-21, 2021-22, 2022-23 and 2023-24** in the same name / firm com position in which he is applying for this tender. In case of change in the name of the firm/company due to merger/acquisition/take over, the documentary evidence in support of the same should be f urnished.

Audited copies of the Balance Sheets and Profit & Loss Accounts for years 2020-21, 2021-22 and 2022-23 should be duly attached. However, unaudited reports certified by chartered accountant/Chartered Accountant's Certificate for F.Y.2023-24 shall be accepted.

(ii) Networth: The tenderer must have a positive net worth based upon latest completed (audited) an nual accounts.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
